The 'AA' rating assigned to Oklahoma Development Finance Authority's \$14,085,000 master real property lease revenue bonds, series 2026A, one notch below the state's Long-Term Issuer Default Rating, reflects the slightly higher degree of optionality associated with payment of appropriation debt.
